The following are incoming wiring instructions for Wrentham Cooperative Bank customers who wish to have funds wired to their account at the bank. Missing or incorrect information may result in funds being returned to the sender, processing delays, or fees incurred. Please contact us at 508-384-6101 with any questions prior to initiating wire transfers into your account.

Domestic Incoming Wire Transfers: for wires originated from within the U.S. use either method 1 or method 2

Method 1: (via our correspondent)

When using this method, ensure you include Wrentham Cooperative Bank as the Beneficiary Bank (or Beneficiary FI). If this field is missing, the wire will reject and be subject to processing delays.
